Training Requirement

Local Law 196 of 2017 requires certain workers and supervisors to receive safety training at construction sites that are required to designate a Construction Superintendent, Site

Safety Coordinator or Site Safety Manager. By September 1, 2020, workers will need a total of 40 hours of training to qualify for a Site Safety Training (SST) card.

Audience

Workers who have completed a 10HR OSHA Construction Health and Safety Program may use this course in place of a 8HR Site Safety Manager Refresher / Chapter 33 course to help fulfill SST requirements before the December 1st, 2019 deadline . Those workers who have already completed both the 10HR OSHA Construction and 8HR SSM / Chap. 33 course may use this course bundle to fulfill the Specialized and General Elective SST requirements before September 1st, 2020's deadline as well.

Course Description
